AN ORDER RECONSTITUTING THE MUNICIPAL TOURISM DEVELOPMENT COUNCIL COMPOSITION AND ITS DUTIES AND FUNCTIONS AND DESIGNATING MS. MARLEEN PERPETUA M. GO AS TOURISM OFFICER

WHEREAS, the State declares tourism as an indispensable element of the national economy and an industry of national interest and importance, which must be harnessed an engine of socio-economic growth and cultural affirmation to generate investment, foreign exchange and employment, and to continue to mold and enhanced sense of national pride of all Filipinos;

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, Local Government Units (LGUs) shall prepare, adopt, implement and monitor their local tourism purposes;

WHEREAS, LGUs shall adopt the principle of sustainable tourism development in the formulation of their local tourism development plans to give due regard to the conservation of natural endowments and preservation of cultural heritage while according opportunity for local communities to achieve a better quality of life;

WHEREAS, due to assumption to office of some newly elected/appointed local officials, brought about by the 2019 national and local elections, there is a need to reconstitute the Municipal Tourism Development Council;

NOW THEREFORE, I, AUGUSTO LEO M. LIVELO, Municipal Mayor of Mogpog, Marinduque by virtue of the power vested in me by law do hereby order the re-constitution of the Municipal Tourism Development Council as a coordinating and advisory body of the Municipal Development efforts and designate **Ms. MARLEEN PERPETUA M. GO** as the Municipal Tourism Officer.


Section 2. Functions and Duties of the Municipal Development Tourism Council. The council shall have the following duties and functions:

- a. Formulate a strategic plan or a framework plan to develop and enhance the tourism potentials and tourism industry in the Municipality of Mogpog;
- b. Coordinate every tourism events and programs in the community;
- c. Formulate programs and recommendation to develop local tourism facilities and attraction tapping local and outside resources and funds;
- d. Assist in the regulation and supervision of tourism-oriented establishments thereby ensuring wholesome and clean tourism activities;
- e. Assist in monitoring the implementation of the Local Government Code particularly on the matter of licensing of tourism establishment in the locality in order to ensure a safe and enjoyable stay of the tourists and travellers.

Section 3. Effectivity

This Executive Order shall take effect immediately.
