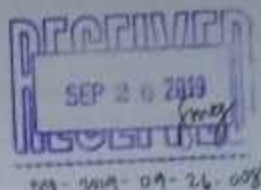

**EXECUTIVE ORDER NO. 2019 - 47**

**AN ORDER REORGANIZING THE MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (MCAT-VAWC)**

**WHEREAS**, Republic Act 8208 declares that the State shall give highest priority to the enactment of measures and development of programs that will promote human dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation and reintegration;

**WHEREAS**, Republic Act 9262 on the other hand, underscores the commitment of the State in safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

**WHEREAS**, the aforementioned laws provide stronger mandates and direction to relevant government agencies and stakeholders to immediately address human trafficking and VAWC by organizing the Inter-Agency Councils (IACs) for trafficking (Section 20 of RA 9208) and VAWC (Section 39 of RA 9262);

**WHEREAS**, DILG-DSWD-DOJ Joint Memorandum Circular No. 2010-1 dated October 18, 2010 was issued to provide basic standards for establishing local anti-trafficking and VAWC committee;

**NOW THEREFORE, I, AUGUSTO LEO M. LIVELO**, Municipal Mayor of Mogpog, Marinduque, by virtue of the powers vested in me by the law, do hereby order the reorganization of the Municipal Committee on Anti-Trafficking and Violence Against Women and their Children (MCAT-VAWC)

**SECTION 1. Composition.** The MCAT-VAWC is composed of the following:


**SECTION 2. Duties and Functions.**

**The MCAT-VAWC shall have the following functions:**

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local ordinances and resolutions)
2. Create and establish systems on surveillance, investigation and rescue to ensure effective and efficient coordination;
3. Undertake information, education and advocacy campaign against trafficking in persons and VAWC;
4. Monitor and oversee the strict implementation of RA 9208, RA9262 and other related laws for the protection of women and children and of the IACAT and VAWC national plan of action.

**SECTION 3. Effectivity.** This Executive Order shall take effect immediately.
