EXECUTIVE ORDER NO. 2019 - 53

AN ORDER REORGANIZING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN

WHEREAS, Republic Act No. 7610 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act) provides for the stronger deterrence and special protection against child abuse, exploitation and discrimination and its corresponding penalties;

WHEREAS, Article 359 and 360 of the Civil Code of the Philippines provides that "The government shall establish councils for the Protection of Children";

WHEREAS, RA 8980 otherwise known as the Early Childhood Care and Development (ECCD) Act promulgates a comprehensive policy and national system from children 0-6 years old, Section 8 (VIII) of the said law requires the organization of the National ECCD Coordinating Council (ECCDCC) and coordinating committees at all levels except in the barangay where the BCPC already exists;

WHEREAS, since LCPC and ECCDCC have the same goals and objectives, both shall function as one to avoid confusion and duplication of similar councils, committees in the LGUs. The Municipal for the Protection of Children shall be the umbrella organization for all programs on children and the ECCD Coordinating Committee shall be one of the committees under it;

WHEREAS, there is a need to reorganize the existing Municipal Council for the Protection of Children together with Municipal ECCDCC to effectively carryout its objectives;

WHEREAS, due to changes brought about by the May 2016 National and Local Elections and retirement/separation of some members, there is a need for its reorganization;

NOW THEREFORE, I, AUGUSTO LEO M. LIVELO, Municipal Mayor of Mogpog, Marinduque, by the power vested in me by law, do hereby order:

Section 1. REORGANIZATION OF THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN. The Municipal Council for the Protection of the Children is hereby reorganized to be composed of the following:

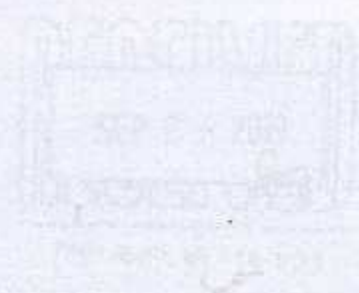

Section 2. **DUTIES AND FUNCTIONS.** The Municipal Council for the Protection of Children have the following duties and functions.

1. Formulate plans, programs and policies for children that are gender-fair, culturally relevant and responsive to the needs of diverse group of children from zero – 18 years of age.
2. Prepare Annual Working Financial Plan for Children and recommend appropriation to the Sanggunian.
3. Provide coordinative linkages with other agencies and institution in the planning, monitoring and evaluation of plans for children.
4. Provide technical assistance and recommend financial support to the Barangay Council for the Protection of Children.
5. Establish and maintain database on children in the municipality.
6. Foster education of every child.
7. Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development.
8. Recommend local legislations promoting child survival, protection, participation and development, especially on the quality of television shows, media prints and coverage, which are detrimental to children, and with appropriate funding support.
9. Assist children in need of special protection and refer cases filed against child abusers to proper agencies/institutions.
10. Conduct capability-building programs to enhance knowledge and skills in handling children's program.
11. Document barangay best practices on children.
12. Monitor and evaluate the Implementation of the program and submit quarterly status reports to the Regional Committee for the Welfare of Children (RCWC).
13. Perform such other functions as provided for in the ECCD and other child related laws.



Section 3. **EFFECTIVITY.** This order shall take effect immediately.
