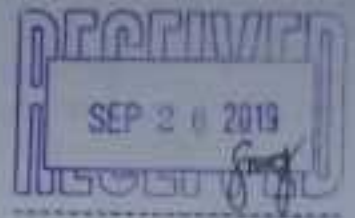

Executive Order No. 2019 - 56

AN ORDER REORGANIZING THE LOCAL COUNCIL FOR CULTURE AND THE ARTS OF THE MUNICIPALITY OF MOGPOG

WHEREAS, by the Municipal Resolution No. 111 – 2012 and the Municipal Ordinance No. 2012 – 170, Section 3, The Local Council for Culture and the Arts of Mogpog was created to serve as advisory committee, formulate and implement policies for culture and the arts of Mogpog;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that Local Government Units play important role in the development, promotion and preservation of Filipino culture to encourage the participation of the people in the development and preservation of Filipino identity;

WHEREAS, to promote this Filipino Culture and Identity, instill nationhood and cultural unity, raise the level of consciousness of the people, the local sanggunians have established local councils whose purpose is the promotion of culture and arts, coordinate with government agencies and non-government organizations for the support and development of our cultural heritage;

WHEREAS, the creation of Mogpog Municipal Council for Culture and the Arts is deemed necessary in order to protect, preserve, revive, develop and uplift our culture, customs and traditions, as well as the arts;

WHEREAS, due to assumption of office of some newly elected/appointed local officials, brought about by the 2019 National and Local Elections, there is need to reorganize the Local Council for Culture and Arts of the Municipality of Mogpog;

NOW, THEREFORE, I, Augusto Leo M. Livelo, Municipal Mayor of Mogpog, Marinduque, by virtue of the powers vested in me by law, do hereby order:

Section 1. REORGANIZATION OF THE MUNICIPAL COUNCIL FOR CULTURE AND THE ARTS OF MOGPOG. The Local Council for Culture and the Arts of the Municipality of Mogpog is hereby reorganize whose mandate, powers and functions are stipulated clearly in Section 6 and Section 7, respectively, of the Municipal Ordinance No. 2012 – 170;

Section 2. COMPOSITION & TERM OF OFFICE. As per Section 4 of the Municipal Ordinance No. 2012 – 170, this Council shall be composed of the following person/representatives whose term of office is embodied in Section 5 of the said Municipal Ordinance.

Section 2: DUTIES & FUNCTIONS OF THE COUNCIL:

1. Set up a municipal wide network of barangay councils for culture and the arts to insure optimum people based participation.
2. Organize a Secretariat for the Council's day-to-day operations
3. Network – with international, national and local cultural and artistic groups/agencies.
4. Link up with government and non-government agencies.
5. Advise the Municipal Mayor on all matters pertaining to culture and the arts
6. Accept donations from both public and private sectors.
7. Mount fund-raising projects.
8. Craft the implementing rules and regulations as stated in the Municipal Ordinance No. 2012-170.
9. Formulate the annual budget of the Council and submit it to the Municipal Mayor for inclusion in the annual municipal budget.
10. Perform other functions which may be necessary for the preservation/conservation of cultural heritage/properties.

Section 3: Effectivity: This order shall take effect immediately.
