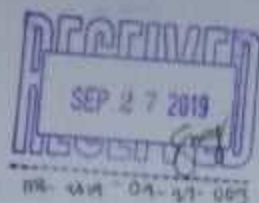

**EXECUTIVE ORDER NO. 2019 - 59**

**AN ORDER REORGANIZING THE MUNICIPAL PROJECT MONITORING COMMITTEE (MPMC)**

**WHEREAS**, Executive order No. 376 s. 1989, as amended by EO 93 s. 1993, established the regional Project Monitoring and Evaluation System (RPMES) to facilitate project implementation and devolved facilitation, problem-solving, monitoring and evaluation of foreign and locally-funded projects to the sub-national level;

**WHEREAS**, as provided for under the aforementioned EO, Project Monitoring Committee (PMC) originally established as the monitoring arm of the Local Development Councils under Memorandum Circular No. 175 dated May 23, 1988 were tapped to operationalize the RPMES at the sub-regional level;

**WHEREAS**, the scope and coverage of PMS monitoring responsibilities were also expanded to include the following: 1) foreign and nationally-funded projects including development projects from the Internal Revenue Allotment (IRA) share of LGUs supported by funds directly to the municipality and 2) projects funded from locally-generated resources which are implemented within their respective areas;

**WHEREAS**, Regional Development Council Memorandum Circular No. 12-001 dated December 12, 2014 enjoined LGUs to reorganize its respective LPMCs to strengthen the capacity of the provincial/municipal project monitoring committee to operationalize the primary objective of the RPMES and raise the level of awareness on the importance of monitoring and evaluation;

**NOW, THEREFORE, I, AUGUSTO LEO M. LIVELO**, Municipal Mayor of Mogpog, Marinduque by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Project Monitoring Committee in this municipality.


## **Section 2. Functions**

1. The Municipal PMC Secretariat shall prepare its monitoring work program for the calendar year;
2. Project implementers shall prepare and submit project status report on project implementation to the Municipal PMC;
3. CSO members of the PMC and other independent CSOs shall submit project inspection report to the MPMC copy furnished the implementers;
4. MPMC processes CSO and agency/LGU reports and conduct project visits to selected projects as identified in the municipal monitoring work program;
5. MPMC processes reports of various implementers and provide the MDC a consolidated report on the status of project implementation in the municipality;
6. Evaluates issues and problems and recommend appropriate actions to be taken by the MDC;
7. MDC assesses reports and take proper action and refer it to the appropriate agencies or council;
8. Implementers take remedial actions in issues and problems encountered in the project implementation and if after a period of reasonable time, no remedial measures or appropriate actions have in taken on the problems, referred to the concerned agency, the MDC and the MPMC shall forward the same to the PDC;
9. It shall provide feedback to concerned implementers in the LGU, CSOs and other agencies to follow implementation remedial measures;
10. It shall forward the consolidated report on project implementation to the Provincial PMC.

## **Section 3. Effectivity**

This Order shall take effect immediately.
