EXECUTIVE ORDER NO. 2019 - 45

AN ORDER REORGANIZING THE MUNICIPAL SCHOOL BOARD OF MOGPOG

WHEREAS, Section 98, Title Four of R.A. 7160, otherwise known as the Local Government Code of 1991 provides for the creation of Local School Boards in every province, city or municipality;

WHEREAS, DILG Memorandum Circular No. 2016-17 provides for the guidelines and procedures on the 2016 Accreditation of Civil Society Organizations for the selection of Civil Society Organizations to sit in the Local Special Bodies and Selection of Representatives to the Local Special Bodies;

WHEREAS, the selection process was conducted by the DILG Mogpog Field Office and there is a need to further reorganize the board after selection for CSOs has been made to sit as representatives;

NOW THEREFORE, I, AUGUSTO LEO M. LIVELO, Municipal Mayor, Mogpog, Marinduque, by virtue of the powers vested in me by law, do hereby order:

Section 1. REORGANIZATION OF THE MUNICIPAL SCHOOL BOARD OF MOGPOG. The Municipal School Board of Mogpog is hereby reorganized with the following composition:

Section 2. DUTIES AND FUNCTIONS: The Municipal School Board of Mogpog shall perform the following duties and functions:


- a) Determine, in accordance with the criteria set by the Department of Education the annual supplementary budgetary needs for the operation and maintenance of public schools within the municipality, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the ZSpecial Education Fund and such other sources of revenue as laws and ordinance may provide;

- b) Authorize the municipal treasurer, to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with existing rules and regulations;
- c) Serve as an advisory committee to the sanggunian concerned on educational matters such as, but not limited to, the necessity for and the uses of local appropriations for educational purposes;
- d) Recommend changes in the names of public schools within the territorial jurisdiction of the local government unit enactment by the sanggunian concerned.

Section 3. EFFECTIVITY. The reorganization of the Municipal School Board shall take effect immediately.

This order shall take effect immediately.
