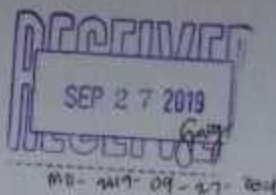

EXECUTIVE ORDER NO. 2019 - 60

AN ORDER RE-ESTABLISHING THE SPECIAL DRUG EDUCATION CENTER (SDEC) AND REORGANIZING THE MUNICIPAL SPECIAL DRUG EDUCATION CENTER TEAM (MSDEC)

WHEREAS, Section 46 RA 9196 otherwise known as the Comprehensive Dangerous Drug Act of 2001 provides for the establishment of Special Education Drug Center for out of School Youth and street children;

WHEREAS, the Dangerous Board provides guidelines on the establishment and operationalization of the Special Drug Education Center (SDEC), with a community based facility, which serve a venue promoting preventive and development services for the youth and street children;

WHEREAS, this SDEC shall promote programs to drug abuse prevention with the end view of educating the OSY and Street Children regarding the pernicious effect of drug hereby contributing to their development as self-reliant and sociality of the function;

WHEREAS, the municipality has a portion assigned the Police Community Precinct 2 as its center, to cater the function of the Municipal Special Drug Education Center (MSDEC) Team;

WHEREAS, due to changes brought about by the May 2016 National and Local Election and retirement/separation of some members, there is a need for its reorganization;

NOW THEREFORE, I, **AUGUSTO LEO M. LIVELO**, Municipal Mayor of Mogpog, Marinduque, by virtue of the powers vested in me by the Local Government Code of 1991, do hereby order reorganizing of Special Drug Education Team and re-establishing of the SDEC with organization, composition and function to wit:

Section 1. **RE-ESTABLISHING OF SPECIAL DRUG EDUCATION CENTER (SDEC) OF MOGPOG**, is hereby reorganize which shall be composed of the following:

Section 2. POWERS AND FUNCTIONS:

1. Develop and implement programs and services on drug abuse prevention among the OSY and Street Children and coordinate/integrate/utilize related activities and service of other agencies. Program and activities may include the components under DDB regulation No. 1s, 2003,
2. Operate and manage the SDEC according to established guidelines set by the DSWD,
3. Provide the facilities, funds personnel, supplies, materials and equipment necessary in the management of the center and implementation of drug abuse prevention activities,
4. Identify target clientele and manage their cases,
5. Ensure that the SDEC complies with the standard developed on the operation of the center as approved by the Dangerous Drug Board (DDB),
6. Organize and mobilize volunteers to assist in the implementation of drug abuse prevention program, in coordination with the MSWDO,
7. Conduct regular monitoring and evaluation of the SDEC following the standards set, including documentation of the operation of SDEC in the implementation of drug abuse prevention program,
8. Submit quarterly/annual reports to the dangerous Drug Board copy furnished the DSWD and DILG,
9. Features of the center and its implementing Guides are identified under DILG Memorandum Circular No. 7006 150 and Dangerous Drug Board (DDB) Regulation No. 1s, 2003 formulated under the provisions of RA 7165 otherwise known as the Comprehensive Dangerous Act of 2003.

Section 3. EFFECTIVITY. This Order shall take effect immediately.
