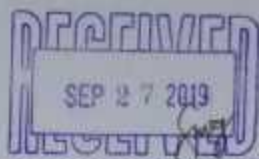

Executive Order No. 2019 - 61

AN ORDER REORGANIZING THE MUNICIPAL HOUSING BOARD OF MOGPOG

WHEREAS, Executive Order No. 708, s. of 2008, provides for the creation of the Municipal Housing Board, supplemented by Municipal Ordinance No. 2010-148 dated December 06, 2010 of the Sangguniang Bayan of Mogpog, this province,

WHEREAS, the Board is the sole clearing house for eviction of demolition activities concerning informal settlers in danger areas, public places and government projects;

WHEREAS, DILG MC No. 2010-08 dated July 26, 2010, directs all Local Chief Executives (LCE) to strictly enforce the easement standard of three (3) meters on both sides of national road and protect the road of right way from intrusion of illegal structures;

WHEREAS, due to some changes brought about by previous election and retirement/appointment of some members, there is a need to reorganize this board;

NOW THEREFORE, I, **AUGUSTO LEO M. LIVELO**, Municipal Mayor of Mogpog, Marinduque, by virtue of the powers vested in me by law, do hereby order :

SECTION 1. REORGANIZING OF THE MUNICIPAL HOUSING BOARD OF MOGPOG. The Municipal Housing Board of Mogpog, hereinafter referred as MHB, is hereby reorganized which shall be composed of the following:

SECTION 2: Powers and Functions. The Municipal Housing Board of Mogpog shall have the following powers and functions:

1. Monitor all evictions and demolitions, whether voluntary, extra-judicial, summary or court-order;
2. Require the proponent of eviction and demolition, i.e., national government agency, institution of local government or its duly authorized representative, to first secure from the Board, the checklist, guidelines of eviction and Demolition Compliance Certificate prior to the actual implementation thereof and thereafter to submit to the Board the completed checklist, attested to under Oath by the proponent indicating that:
 - a.) Adequate consultation with the affected families were undertaken
 - b.) Adequate resettlement site relocation facilities are made available
 - c.) Provisions of Section 3, par. 1 of the IRR of Section 28 of R.A. No. 7279 (Pre-location) have been complied with

SECTION 3: Effectivity. This order shall take effect immediately.
