EXECUTIVE ORDER NO. 2019 - 67

AN ORDER REORGANIZING THE LOCAL PRICE COORDINATING COUNCIL COMPOSITION AND DEFINING ITS POWER AND FUNCTIONS IN THE MUNICIPALITY OF MOGPOG

WHEREAS, Section 5 of the Implementing Rules and Regulations of Republic Act No 7581 (Price Act 1991) mandated the creation of the Local Price Coordinating Council in the Municipality of Mogpog;

WHEREAS, the LPCC had a short-lived existence, thus, implementation registered a great drawback with the change in administration and management attributed to the electoral process;

WHEREAS, this complete hibernation of the facility brought to the fare existence prices of prime commodities in the market particularly fish and other marine products and by which price escalation apparently became at the mercy of our fish vendors;

WHEREAS, price escalation, exorbitant and overpriced basic commodities particularly fish and marine products undeniably distraught the buying public;

NOW THEREFORE, I, **AUGUSTO LEO M. LIVELO**, by virtue of the powers vested in me by law, do hereby order and direct the Re-Creation of the Municipal Price Coordinating Council:

SECTION 1. REORGANIZATION OF THE LOCAL PRICE COORDINATING COUNCIL OF MOGPOG. The Municipal Price Coordinating Council of Mogpog is hereby reorganized with the following composition:

SECTION 2. DUTIES AND FUNCTIONS. The Municipal Price Coordinating Council shall have the following duties and functions:

1. Coordinate and rationalize programs of implementing agencies to stabilize price and supply at the local level;
2. Recommend to the National Price Coordinating Council (NPCC) or to the implementing agencies suggested retail prices and/or price ceilings for certain basic necessities and prime commodities in respective areas;
3. Analysis causes of price fluctuations and recommend actions to stabilize price and supply ;

SECTION 3. Meeting. The Municipal Price Coordinating Council shall meet at least once every quarter or as may be necessary.

SECTION 4. EFFECTIVITY. This order shall take effect immediately
